

## **Rebuilding an Affiliate from Scratch**

**T**he year 2010 was a journey of creation for the **Nebraska Association for Food Protection (NAFF)**. Though Nebraska has had an affiliate for many years (formerly the Nebraska Association of Milk and Food Sanitarians), our Affiliate had been idle in recent years. In 2010, several Members decided to change that.

We are fortunate to have a food science program at the University of Nebraska–Lincoln, so our first meeting was held there. Through the di-

The most challenging part of starting a new group is building the membership and finding available locations. Following our first meeting at UNL, where we established the board, we held our next meeting at BCG Solutions. There we learned about the cutting-edge technologies they have developed and were able to try out a few of those.

At our next meeting, again at UNL, we had a presentation on the capabilities of the food processing center. We got to tour the center and see the different equipment and needs of the university program. Cargill, who generously hosted our next meeting, allowed us to explore their site and the symbiotic relationships between them and their business partners. Discussions also took place on the latest legislation coming out on HACCP requirements. ConAgra afforded us a presentation and discussions on sanitary design.

Membership was raised mainly through word-of-mouth and from those in Nebraska who joined the International Association for Food Protection. The strongest drive came from canvassing area businesses prior to our Annual Meeting: We received a great response with new companies and individual Members who were drawn to the big event.

The Nebraska chapter, renamed the Nebraska Association for Food Protection to better tie in with the goals of IAFP, was granted its charter in April, and officially received it at **IAFP 2010** in Anaheim, California on August 1.

In November, we held our first Annual Meeting in Omaha. Preparations included getting the word out about our new organization. Members canvassed their respective areas with flyers and brochures. **Carter** with Silliker Labs talking about “Laboratory Micro Analysis and Validation;” a GFSI Panel Discussion featuring **Brandon Headlee** with ConAgra Foods, **Roger Bont** with Cargill, **George Gauser** with IFS North America, and **Jayne Stratton** and **Andreia Bianchini** with The Food Processing Center at UNL; and “Consumer and Retail Insights” into recalls and interventions with input from **Scott Brooks** with YUM! Brands, **Joan Menke** with ConAgra Foods, and **John Butts** with Land O’Frost.

**Metropolitan Association for Food Protection: Fall Seminar a Success!**

The **Metropolitan Association for Food Protection (MAFP)** held its 2010 Fall Seminar at Rutgers University, New Brunswick, NJ on October 13. Over 100 attendees from government and industry were on hand to hear five presentations addressing current topics and challenges facing food safety professionals today.

**Stan Bailey**, bioMérieux Industry, presented “*Salmonella*, Prevention and Control.” He gave the audience a great lesson in *Salmonella* 101 and the growing concern for controlling *salmonella* in not only the poultry industry but in products such as eggs and peanut butter, as well as pep-

pers and other vegetables. In addition, as IAFP Past President, he spoke of the benefits of membership in the Association. **Rich Gibson**, RK Environmental Services, presented “GFSI—Global Food Safety Initiatives.” Rich discussed the history, objectives, and audit schemes of the GFSI and some of the best-known programs that are part of the GFSI, such as SQF (Safe Quality Food) and BRC (British Retail Consortium). **James Borda** and **Joseph Priore**, USDA FSIS, gave a detailed presentation on “Procedures for Evidence Collection,” discussing the objectives, references, priorities, and sampling techniques used by the USDA in evidence collection. **Kevin Byrne**, American Almost Products, talked about “Critical Paths to an Effective Allergen Control Program,” touching on the “Big Eight” products, the most common allergens. He discussed how to achieve a written program that entails policy, scope, facility practices, and employee practices

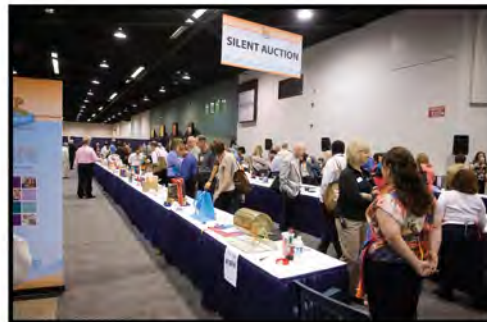

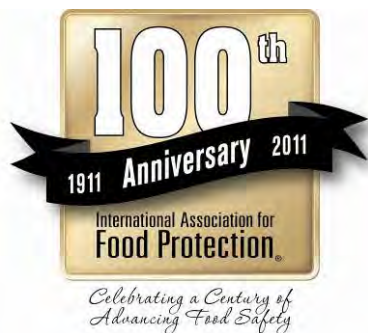
